Sub.: Request to encourage students studying in State Board Schools to apply for the Common University Entrance Test [(CUET (UG)) - 2024 — reg.

Respected Sir/Ma'am,

As you may be aware, the National Testing Agency has been mandated by the **Ministry of Education and UGC** to conduct the **Common University Entrance Test (CUET)** for admission into **Undergraduate Programmes in Central Universities under the Ministry of Education, and other participating Universities / Institutions / Organizations / Autonomous Colleges** since the year 2022.

The CUET (UG) provides a **single window opportunity to students seeking admission in any of the Central Universities (CUs) or other participating organizations (including State Universities, Deemed and Private Universities) across the Country.**

I would like to draw your attention to the Public Notice dated 27 February 2024 issued by NTA regarding timelines for the conduct of CUET (UG) - 2024 along with other relevant details. For the academic session 2024-25, CUET (UG) 2024 will be conducted in the Hybrid mode between 15 May and 31 May 2024 in 13 languages. The result for the same is likely to be declared by 30 June 2023. The date(s) may vary depending on the National Election Schedule.

The list of participating universities is displayed on NTA's website <https://exams.nta.ac.in/CUET-UG/>. The list of participating universities, as displayed on NTA's website, is dynamic and is updated on continuous basis. It is further informed that in CUET (UG) - 2023, around 15 lakhs students participated. For the Academic year 2024-25, the registration process is still going on. It is our collective responsibility that students are made aware about registration in CUET (UG) – 2024 through website <https://exams.nta.ac.in/CUET-UG/> and the benefits which it brings to the students.

Accordingly, you are requested to inform all the State Board Schools in your State to ask the students to register in CUET – UG 2024 on the website <https://exams.nta.ac.in/CUET-UG/>
